## Princeton Bicycle Advisory Committee 2018 Goals

Work with Engineering Department to (a) identify the top three near-term priorities in the Bicycle Master Plan, and (b) establish timeline for implementation/construction of those projects. Vision Zero principles of speed and injury reduction should be considered in the decisions.

With municipal decision makers, develop and implement procedures to ensure that PBAC and the Complete Streets Committee are routinely included in early planning stages of street reconstruction, including municipal, and when Princeton's Complete Streets policy may be affected, county and state.

Work with Traffic Calming Subcommittee of Complete Streets Committee to identify strategies and top priorities--based on objective criteria--for traffic calming targets to achieve speed reduction. This action aligns with Vision Zero.

Work with engineering, police, public works departments and schools to prepare Weeklong Pop-up Bike Lane in May 2018: Bike To Work / School Week.

Work with Sustainable Princeton to make recommendations to climate action plan on goals for walking and biking as low-carbon transportation modes.

Work with municipality and businesses to ensure adequate bicycle parking at major community events such as Communiversity, jazz festival.

## If time allows in 2018:

Work with police to encourage compliance with and/or enforce NJ laws for bicycle safety requiring bicycle helmets for those under 17, bells on bicycles, lights on bicycles at night time. Work with partners including the school district, the public library, and others to disseminate information to general public and students about bicycle safety laws—for cyclists *and* drivers.
