V. PLEDGE OF ALLEGIANCE

The audience participated in the pledge of allegiance.

VI. ANNOUNCEMENTS

Mr. Liverman announced that Corner House, Princeton Police, Princeton Schools and Princeton Alcohol Drug Alliance will be sponsoring a Marijuana Forum on May 24, 2017 at 7:00 p.m. at the John Witherspoon Middle School.

Mr. Quinn announced that May 23, 2017 is Bike or Walk to school day at the Riverside School.

Mayor Lempert noted that the Bike Rodeo and Cyclovia events were held this past weekend. She also announced that the Spirit of Princeton Memorial Day Parade is May 27, 2017 beginning at 10:00 a.m. along Nassau Street. She also said that the Municipality is now using a computer system called Seamless Docs and that various forms are available on the website to complete and submit on line to the Municipality.

Ms. Crumiller and Mr. Miller had no announcements.

Ms. Stockton said that there are nine days left for resident's to participate in the parking survey and that so far over 1,500 people have participated. She also announced a parking meeting with the parking consultants Nelson\Nygaard scheduled for June 14, 2017 beginning at 5:30 p.m., at Witherspoon Hall.

VII. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON AGENDA

Yaritza Perez, Church of God, addressed Council concerning community outreach and their mission to serve the community through volunteer work. She said they recently participated in a clean- up at Marquand Park and would like to continue a relationship with Princeton.

VIII. PRESENTATION

1. Pilot Parking Program, Possumus, Inc.

Arash Sadeghi, Lead Engineer, Possumus, Inc., reviewed with Council a presentation concerning a pilot parking program for Princeton concerning smart parking meters. The smart parking meters are equipped with cameras and are capable of communicating with motorists' cell phones and alert them to open spaces and to allow them to reserve a space before they even get to it. The smart meters will be equipped with a beacon that changes color as its status changes. A blinking green light means that it's available to anyone participating in the program; red indicates that it has been reserved for an approaching motorist or that no parking is allowed at that time. When the motorist parks, the rate and time limitations for that spot will be displayed on your cell phone. (Presentation attached)

IX. REPORTS

1. March 2017 Police Report

Chief Sutter highlighted a new partnership the Department has formed through Corner House with Recovery Advocates of America called the CARE Program. He said Princeton police officers who come into contact with someone suffering from addiction, will ask the person if they want help in fighting the addiction. If the person says they need help, Recovery Advocates of America will be contacted immediately. A representative will respond within thirty minutes to help start the recovery process.

Chief Sutter reviewed the March 2017 Police Report with Council. (Report attached)

Mr. Liverman asked Chief Sutter to report on the Police Officer's that rode bicycles in the National Law Enforcement Memorial Week ride. Chief Sutter said that several officers rode bicycles, which left from Mercer County Community College and rode to Washington DC in honor of our fallen officers.

Mr. Liverman reported that he read that it was National Emergency Medical Service's Week and said he wanted to thank the Princeton First Aid and Rescue Squad.

Ms. Stockton reported that New Jersey American Water will be holding a neighborhood meeting on May 31, 2017 at 7:00 p.m. in the Community Room to present its project which will take place on Route 27 from Harrison Street to Snowden Lane for replacing the water main and services.

Mayor Lempert read the proposed ordinance by title.

Mr. Liverman stated that these meters do not accept nickels and dimes and they do not have the ten minute grace period that the municipal parking meters have. Mayor Lempert stated that this is a private lot and it does not use our standard meters. Mr. Miller said he is opposed to this ordinance, the owner retains the revenue from the meters and municipality retains the revenue from the fines. He said there is very little gain for the municipality. Ms. Crumiller said she shares Mr. Miller's concerns, but that having additional parking available to the public is a benefit. She also said that she wants the signage in the lot to be very clear concerning the meters.

Mayor Lempert opened the public hearing.

David Cohen, 135 Terhune Road, asked for an explanation of "Title 39 Jurisdiction". Chief Sutter responded that it is the State code that gives local police the authority to enforce laws that are enforced on public roads ways to be enforced on private property.

Ms. Crumiller stated that the Public Works Committee has endorsed these rates and that Sustainable Princeton and staff had looked at other charging station facilities and worked out what the fees should be and that the fees will encourage turnover.

Dunbar P. Birnie, 60 Laurel Road, addressed Council concerning the rate structure saying that the fee structure is high and will discourage users from choosing to park there and that Council should reconsider not charging a fee for the electricity. (Comments attached)

Mara Olmstead, 42 Wilkinson Way, said that she supports the speed limit being lowered on Hutchinson Drive and along with the Route 206 bridge work detouring the traffic through Washington Oaks, she would like to see it reduced to 25 m.p.h., but she appreciates Council looking at this issue.

Ms. Crumiller asked about signage at the crosswalk at Hutchinson Drive. Ms. Stockton stated Sgt. Murry is looking at the signage and that some improvements have been made with the removal of vegetation that was blocking the site lines. Ms. Stockton said they will continue to monitor this during the detour and that the Police will be posting a “*your speed is*” sign in that area.

Mindy Richardson, General Manager, McCarter Theatre, said that they appreciate Council providing three (3) hour short term parking meters but would prefer the short term parking spaces on University Place to be south of the crosswalk. She said it would cut down on confusion concerning the short term vs. long term parking on University Place. She said she is asking if Council does move forward with the proposed ordinance, that Council consider the timing of this action, as twelve (12) parking spaces are still unavailable due to the Lewis Center Construction.

Mayor Lempert closed the public hearing.

Ms. Stockton said from what she understands from Princeton University, the remainder of spaces from the Lewis Center Construction should come back on line at some point in August.

Ms. Crumiller suggested that Council either take the ordinance as proposed or table the ordinance to look at these concerns.

Ms. Stockton said that this area is part of the parking study currently underway.

After discussion it was the consensus of Council to carry the public hearing to June 26, 2017 to see if additional information can be obtained from the parking consultants.

RE: EV charging revenue comments

Respected Council Members,

I teach at Rutgers University in the School of Engineering and one of my active strategic projects involves studying EV charging from all aspects, including physical infrastructure and installation costs, usage costs and EV user participation within the context of the general parking policy at Rutgers. My research project home page is: <http://www.rave.rutgers.edu/>

I just learned that you are considering a specific fee structure for future EV charging in Princeton parking garages. Based on my professional experience and study of EV charging at Rutgers, it seems like you are setting up a fee structure that is very high and will discourage users from choosing to park. With that fee then plug-in capable cars will simply choose regular parking spaces and do their charging at home or other locations.

We should most naturally consider the balance of revenue and costs when deciding on a rate structure:


- On the cost side, we obviously have to pay for installation, electricity, and relatively rarely for some repairs. Installation is the lion's share, probably coming in at \$2K-\$5K per station, depending on how close the power sources might be.
- As a comparison to Rutgers where we have relatively heavily EV charging, the total annual electricity cost per spot is less than \$500/spot/year.
- Additionally, we might wonder if dedicating a space to EV-only would impact the revenue of the regular parking; there will be that many fewer spots. However, this cost is only incurred for any hours when ALL the non-EV spots are filled. This might happen at lunch time on certain days and when special events happen, but this might be considered as a small effect.
- On the revenue side, as a baseline we have the regular rental rate, which I think is \$1.25/hour, after the 30-minute grace period. As a quick back-of-the-envelope on baseline usage revenue, assuming average 8 hours/day usage, I calculate a baseline revenue of \$3,650 per year per spot. Note that the regular parking revenue is MUCH larger than the annual electricity costs combined with a possible few-year payback on the installation costs.
- But, if we allocate these spaces as EV-only then they only receive this revenue if those EV-capable users CHOOSE to come and plug-in. So, if the EV rate structure is too high then you will be forfeiting substantial earnings from the simple parking charges alone.

A MUCH better business model would be to figure that these EV spots are competing with other on-street parking and if you offered free EV charging you could earn normal parking fees WAY beyond what the costs would be or if the spots simply remained un-used.

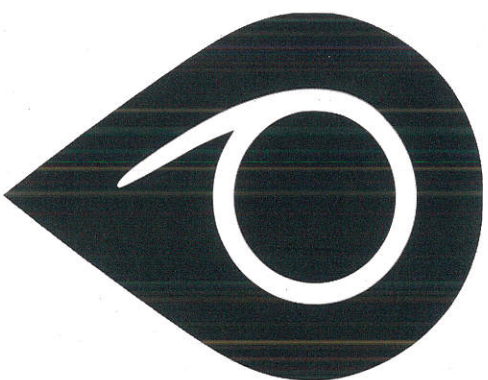
As an academic, I wonder, as an experiment, whether one garage might be fitting with one fee structure and the other a different fee structure – and monitor usage and parking revenue associated with those usages.

As a final note, I should say at Rutgers we offer the electricity free. Faculty and staff already pay large fees for their parking permits. We have decided that any added charge would, as suggested above, dissuade usage. My goal at Rutgers has been to promote more EV usage, which I think is the right strategy for here in Princeton, as well.

RESOLUTION 17-162

Resolution Amending Professional Services Agreements with Jeffrey R. Surenian and Associates, LLC, The Buzak Law Group, LLC and Econsult Solutions, Inc., Nassau Capital Advisors to Represent the Mercer County Municipal Group in the trial on the Fair Share Methodological Issues

WHEREAS, the Municipality of Princeton filed a declaratory judgment action on July 8 2016 captioned *In re Application of Municipality of Princeton, Mercer County*, Docket No. MER-L-1550-15, pursuant to the process set forth in the New Jersey Supreme Court's March 10, 2015 decision in *In re Adoption of N.J.A.C. 5:96 & 5:97 by the New Jersey Council on Affordable Housing*, 221 N.J. 1 (2015); and

WHEREAS, trial began in January 2017 for the methodology that will be used to establish the municipal fair share affordable housing obligations for Princeton and the other municipalities in Mercer County that have pending declaratory judgment actions, including East Windsor Township, Hamilton Township, Hopewell Township, Lawrence Township and West Windsor Township; and

WHEREAS, to facilitate the orderly presentation of the case at trial, the Court required the municipalities and the various interested parties / intervenors to designate trial counsel for each class of parties within the consolidated methodology portion of the case; and

WHEREAS, by Resolution 16-359 adopted on December 19, 2016, the Princeton Council approved the appointment of Jeffrey R. Surenian and Associates ("Surenian") and The Buzak Law Group ("Buzak") as special counsel to represent the collective interests of the Mercer County Municipal Group ("MCMG"), including Princeton, in the trial on the fair share methodological issues; and

WHEREAS, by Resolution 16-359, the Council also approved and authorized the Princeton Mayor and Clerk to enter into professional services agreements with Surenian and Buzak for the said special counsel services, as well as with Econsult Solutions, Inc. ("ESI") and Nassau Capital Advisors, LLC ("Nassau") for expert services during the trial; and




