1. Immigrant Heritage Month in Princeton

Mayor Lempert noted that June is Immigrant Heritage Month in Princeton and encouraged everyone to read the full text of the Proclamation on Municipal website.

#### IX. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

Joshua Zinder, Architect, 142 Moore Street, said he thanks' the Mayor for the increased dialog between the Municipality and the Princeton Merchants Association. He said he is very concerned about vacant store fronts on Nassau Street and at the Princeton Shopping Center and said that this stems from the difficulties in getting approvals from the Municipality. He said approvals from Princeton for change of use of existing spaces, parking for the existing spaces, the historic approval and the signage approval can take six to eight months and could cost \$20,000.00 to \$30,000.00 dollars for engineering, architecture and legal fees. He said this is a huge deterrent to potential tenants. With new developments going up all around Princeton, he said modifying ordinances to support retail, service and food based businesses should be a top agenda item for the remaining part of the year.

Mayor Lempert noted that she, Ms. Butler and Mr. Miller met with staff on this topic and said they understand the problems and will be coming out with a report to address the issues that Mr. Zinder spoke about.

Pascal Chausson, Willow Street, asked when would the release of the sewer easements from a sewer project undertaken on Willow Street in 2014 take place. Ms. Stockton responded that the Attorneys' office is currently working on the new deeds for the release of the sewer easement for the affected properties. Ms. Cecil stated that her office is in the process of completing the new deeds and hopes to complete it quickly.

Allison Neely, 224 Clover Lane, said she is a 27-year faculty member at the Westminster Conservatory and wanted to explain that there are two organizations at Westminster, the Westminster Choir College and the Westminster Conservatory, which she said is the community music school. She said there are over 2,000 students which the community music school started in 1970 as a division of the Choir College. She said that if Westminster Choir College is sold the conservatory will basically be homeless and she is asking Council to keep the Conservatory in their thoughts and conversations.

Andrew Sutphin, 37 Olden Lane, said he is speaking on behalf of the 27 property owners on Olden Lane to ask Council to take action to post "No Thru Traffic" signs or other appropriate language on Olden Lane. He said they are also requesting an ordinance to decrease the weight limit on Olden Lane to four tons. Ms. Stockton responded that they are looking into permanent

signage for Olden Lane but during this time with the Route 206 detour, she will look into having temporary signage installed.

Hendricks Davis, 232 John Street, said he was here again to speak about the Mary Moss Park. He said there is no existing representation that a playground was ever even there. He said there are two huge vacant lots – one the former Mary Moss playground site and the other the passage way from John Street to the Stanworth Properties. He said Council is making a big mistake and missing a big opportunity by continuing in their efforts to establish a playground. He said many residents think affordable housing should be built and on the former site and return that property to the tax rolls and build the playground/park in the pass- through property and to work with Princeton University to achieve this. He said this needs to be said at this time in light of the existing COAH litigation.

Mayor Lempert responded that the Mary Moss Playground project has been approved by Council and that we are working with Habitat for Humanity to create affordable housing on a portion of the site as well.

Glen Schultz, 84 Wheatsheaf Lane, said he is concerned about zoning variances that are granted making homes larger, thus creating drainage issues on his property and asked if Council plans to enforce the zoning ordinances that already exist.

Mayor Lempert responded that the Stormwater Management ordinance on for adoption at tonight's meeting addresses some of that issue and also said the Princeton Neighborhood Character & Zoning Initiative Progress Committee is studying these issues and suggested he look at the progress report that is posted on the Municipal website.

#### X. REPORTS – PARAMEDIC PROGRAM

James Boozan, Director of Emergency Services at Capital Health gave an overview of the Emergency Medical Services (EMS) program. He said Capital Health has been running the paramedic program (mobile intensive care unit) for 40 years and that the units serve all of Mercer County. He reported that Capital Health is relocating a unit back to Princeton and that the ambulance will be housed at the Hook and Ladder Fire House on Harrison Street. He explained that EMS response is a four tier service. He said the first leg of EMS is a 911 dispatcher, followed by Police and Princeton First Aid and Rescue Squad (PFARS), and then the fourth phase is the Capital Health paramedic unit. He said the paramedic units are only dispatched if the circumstances are critical or life-threatening. Paramedics have the ability to interpret an EKG and if a patients' EKG shows a heart attack is happening they notify the hospital ahead of time and the hospital can have the Cardiac Cauterization lab ready. He said Capital Health also has a mobile stroke unit, only one of eight in the United States, that has a CAT scan on board and if the paramedics can determine that there is no bleeding in the brain then they can begin treatment with a medication to break up the clot.

Ms. Howard thanked Mr. Boozan for his briefing and said Capital Health is a compliment to PFARS and that it is exciting that we have this added level of service.

Mr. Liverman asked if the Capital Health employees stay here and if billing is done through the patients' insurance.

Mr. Boozan responded that the employees are trained throughout the County as the unit that is stationed here could respond anywhere in the County. He also said that yes, billing is done through insurance.

Ms. Crumiller asked if the unit is stationed here 24/7 to which Mr. Boozan responded yes and noted that Capital Health has 5 to 6 units throughout the County and that all the units work to cross cover the County.

Mr. Miller thanked Mr. Boozan for speaking and said that this service is an important augmentation to the services provided by PFARS and is a great value to the residents of Princeton.

Ms. Howard reported that the Library and the Human Services Department hosted a Welcoming Week planning meeting today. She said Welcoming Week is scheduled for September 15-24, 2017 and that the goal is to continue to highlight and celebrate the diversity in our Community. She also reported that the Summer Youth Program, starting on July 5, 2017, will have forty-two youth working though out Princeton. Ms. Howard also said that the Princeton Hospital has agreed to expand the free transportation service to the hospital to include Redding Circle.

Mr. Liverman reported that four 10<sup>th</sup> graders have been selected to participate on the Youth Advisory Committee for the 2017/2018 school year. He also reported that the current Youth Advisory Committee just completed a mental health forum that was held at the Public Library.

Mr. Miller reported that at the Citizens Finance Advisory Committee (CFAC) meeting this morning Councilman Quinn suggested the possibility of a forum sometime this fall to be conducted by the CFAC and to be hosted by the Public Library. The purpose of the meeting would be to explain to the public how the municipal budget is put together, the sources of revenue and how the funds are spent. The forum would provide an opportunity for the audience to ask questions concerning the municipal budget process, the budget, and the role and guidance provided to the municipality by the CFAC. The possibility of inviting the Princeton Public Schools and Mercer County to provide similar information and an opportunity for discussion of their budgets was also discussed, but it was concluded that an initial forum should focus on the municipality.

Mr. Miller also reported on the activity of the Shade Tree Commission and Arborist this spring, saying that they celebrated Arbor Day events at five Princeton elementary schools; participated in the Littlebrook School science fair; and along with the Department of Public Works planted 55 trees in the municipal right-a-way and filed a grant request for \$30,000 for the replacement of ash trees that have been or will be lost to the Emerald Ash Borer. He also reported that Princeton is participating in an experimental program with the US Department of Agriculture who are using a test area in Mountain Lakes Nature Preserve which involves the release of parasitic wasps which prey on the Emerald Ash Borer larvae and interrupt the reproduction cycle of the ash bore. He said he wanted to emphasize that parasitic wasps are minuscule insects that are not a hazard to humans. The purpose of the test is to see if a wasp release program would work in a small confined area.

Ms. Crumiller reported that Fay Reiter has been appointed Chair of the Public Transit Committee and said she also wanted to note that the IT Department had sent out a phishing test as part of a training for employees.

Ms. Butler reported that the Community Park Pool will open full time on June 14, 2017 and that 500 new memberships had been issued over the previous weekend and the pool has so far received 4,000 visitors. She also reported that the Recreation Department hosted the special needs BBQ on June 2, 2017 and that the Blue Curtain Concert is scheduled for July 15, 2017. She also said that the Recreation Department has completed hiring for summer employment and that they hired about 171 employees.

Mr. Quinn reported that the Civil Rights Commission held a special meeting on May 30, 2017 where a presentation by Princeton Public Schools Superintendent Steve Cochrane on the district's Racial Literacy Program. Information was shared about disciplinary data in regards to minority students and minority staff recruitment. He also reported that he, Ms. Butler and Mr. Liverman attended the Unity Awards sponsored by Not In Our Town where awards were presented to kids who are really making a difference on race issues.

Mr. Quinn said that in 2016 the Princeton Environmental Commission (PEC) worked on an ordinance regulated the installation of residential electrical vehicle charging stations and during the transition of liaisons to the Commission this ordinance was not included in Councils goals. He said that he is looking for guidance from Council to add this item to the 2017 goals or hold off until 2018.

Ms. Cecil said that there are a lot of different components to this ordinance and some research on this topic needs to be done.

Sophie Glovier, Chair, PEC, said the development of this ordinance came through Sustainable Jersey. Sustainable Jersey was encouraging this to be done, but has since realized that NJ State Building Codes contain items that other states do not require and at this point for New Jersey, it makes sense to put an ordinance off at this time. Mayor Lempert said that it seems premature and that Council should wait on this item.

Mr. Quinn also added that on June 14, 2017 the ribbon cutting for the Electric Vehicle Charging Station at the Spring Street Garage will be held.

Mayor Lempert reported that a new parklet is up and open in front of Jazams and the theme is *Energy Playground* which has interactive spaces that teach about renewable energy. She also thanked the Arts Council, Avalon Bay and everyone who helped bring the public art display entitled *Einstein's Brain*, by sculptor Patrick Strzelec which has been installed front of Avalon Bay.

### XI. ORDINANCE PUBLIC HEARINGS

1. 2017-26 An Ordinance By Princeton Cancelling Special Assessments for the Reconstruction or Installation of Sidewalks Along Moore Street, Park Place, Vandeventer Avenue, Willow Street and Authorizing the Cost of said Improvements as a General Improvement

Mayor Lempert read by title the proposed ordinance and said this ordinance came about as a change in policy from Council to pay 100 percent for sidewalks where the Municipality use to split the cost 50/50 with residents.

Municipal Attorney Cecil recused herself on this ordinance as her father has property on Vandeventer Avenue.

Mayor Lempert open the public hearing. Hearing no public comment, Mayor Lempert closed the public hearing.

Ms. Butler said that this sidewalk work was prior to the change in policy and the residents knew they would be responsible, it enhances their property and the project came in under budget and she said she thinks they should pay as they thought they were going to pay.

2. 2017-27 An Ordinance by Princeton Cancelling Special Assessments for the Reconstruction or Installation of Sidewalks Along Poe Road and Edgehill Street and Authorizing the Cost of said Improvements as a General Improvement

Mayor Lempert read by title the proposed ordinance. Mayor Lempert open the public hearing.

Hendricks Davies, 232 John Street, said he was interested by Ms. Butler comments and asked if this policy can be made retro-active. He said he thinks residents in the poorest neighborhood, the Witherspoon-Jackson neighborhood had to pay. He said it seems out of balance to put this through now when it is not benefitting a broader group and perhaps residents should be encouraged to participate. He said is this really the best use of the resources of the town.

Ms. Crumiller said that this was a policy decision and moving forward residents will not be assessed as we want to promote walkability.

Mr. Miller said there has been a history going back 10 or 11 years where taxpayers were asked to pay 75 percent of the cost of the sidewalk and there has been an increasing recognition of the governing body, in part, that the sidewalks are used by everyone and not just those who live adjacent and as a result the cost of installing or upgrading the sidewalk has gone from the taxpayer to the municipality.

5. 2017-30 An Ordinance by the Municipality of Princeton Regulating Stormwater Management and Amending the "Code of the Borough of Princeton, New Jersey, 1974" and the "Code of the Township of Princeton, New Jersey, 1968"

Mayor Lempert read by title the proposed ordinance. Jack West, Land Use Engineer discussed the harmonization of the former Borough and Township stormwater ordinance and the four major recommendations proposed by the Princeton Environmental Commission and Stony Brook-Millstone Watershed Association which are: the minor development impervious area threshold, major development threshold, impervious surface definition and inspection permit regulations.

Daniel Harris, 28 Dodds Lane, said he supports this proposed ordinance and said that we must all do as much as possible to support sustainability at the local and regional level. We must minimize the pollution of our waters. He commends the Princeton Environmental Commission, Stony Brook-Millstone Watershed Association and the Engineering Department. He said he urges Council to pass this ordinance.

Joshua Zinder, 142 Moore Street, said he believes there is conflicts, ambiguity and missed opportunities as the ordinance stands now. He said this ordinance is not a sustainable strategy for our community and puts a financial burden on the homeowner. He said it will not resolve the stormwater issues on Spring Street and Harrys Brook, which require a comprehensive plan. This ordinance is another case of providing a blanket ordinance across town. He said we should be progressive and offer sustainable strategies and provide opportunities to homeowners to improve their homes, our neighborhoods and not punish taxpayers with undue restrictions for issues we are unable to confront as a municipality.

Jim Waltman, Executive Director, Stony Brook Millstone Watershed Association, said that they support this ordinance, with the understanding it can be strengthened and additional steps taken to work through volunteer means with residents and business. Stormwater runoff is the number one cause of water pollution and flooding. He said additional steps that need to be taken are proposed in a second phase when existing developments are redeveloped to bring them into compliance. He said he also agrees that inspections are critical and supports this first step.

Mr. Waltman read a statement from the Mayor of the Borough of Manville "Princeton's efforts to help set stricter requirements to further reduce stormwater runoff from new development are commendable. Hopefully, Princeton's Mayor and Council will be the "change agents" other can follow to help lower flood water levels all across Central New Jersey".

Mike Pisauro, Policy Director, Stony Brook Millstone Watershed Association, said he echo's Mr. Waltman's comments. He said they have been working since 1972 on water quality issues and said we are not there yet and the reason is because of stormwater. The most significant cause is coming from all our properties, we are all adding to the pollution and flooding and this ordinance helps capture more water and treat more water on site.

Sophie Glovier, 68 Drakes Corner Road, Chair, Princeton Environmental Commission (PEC) said the PEC strongly supports this ordinance and encourages Council to adopt.

Kip Cherry, 24 Dempsey Avenue, said she also supports the ordinance, but it does not go far enough, a maintenance plan is needed for small projects as well. She also said that houses that have been put on higher grading then originally built needs to be looked at.

Wendy Mager, 459 Cherry Hill Road and President of Friends of Princeton Open Space, said she also supports the ordinance, the impact of stormwater run-off is a great concern. She also said they have a rain garden at the Mountain Lakes Nature Preserve and it channels the water from the driveway surface and filters it so it does not run into the lake.

Tatia Lucksom, 151 Taylor Court, said she supports this ordinance and hopes Council continues with the second phase.

Tineke Thio, 79 Dempsey Avenue, said she wants to encourage collaboration between neighbors and neighborhoods. She questioned the 2 gallons per square foot calculations and asked if that is a reasonable amount? Mr. Waltman responded that the amount equates to a 2-year storm and said every town needs a strong ordinance with other approaches and strategies.

Mr. Miller and Mr. Quinn recuse themselves from this ordinance as Mr. Miller's wife is on the Library Board and Mr. Quinn works for the Library.

Ms. Butler asked if this ordinance includes the \$150,000 dollars for surveillance equipment. Mr. Dashield responded that it does. Ms. Butler said she had raised some concerns about the surveillance equipment and said until we investigate what we are doing with it she does not support the purchase of this equipment and will vote against it. Mr. Liverman responded that this is nothing different then what we are doing now, it is just getting better equipment and said the Library is not changing what they currently are doing. Ms. Crumiller said she shares Ms. Butlers' concerns and asked why are library users under surveillance. Ms. Howard responding that the Public Safety Committee discussed this issue and said when in a public place you do not have a reasonable expectation of privacy.

Brett Bonfield, Director, Princeton Public Library, explained that this is for replacement cameras on the first and third floor, cameras have already been installed on the second floor as part of the renovations. He said the Library values privacy and place the cameras for security. He said it does appear that at this time camera footage does not fall under NJ Open Public Records Request (OPRA). He said there is a very lower occurrence of theft but noted that the Library has 800,000 to 850,000 thousand visitors a year, there are issues that do arise and the cameras have proved valuable in enforcing the code of conduct and helping to make sure people's property and children are safe.

Ms. Howard asked when is camera footage used. Mr. Bonfield responded that the times when the cameras have been used have typically have been for petty theft or violating the code of conduct. He said it is important for us to monitor and there are signs informing visitors that the building is under surveillance.

Mayor Lempert closed the public hearing.

Ms. Crumiller said she is glad to know that signs are posted at the Library and previously had been unaware that the Municipal Building was monitored and asked that signs be posted in the Municipal Building that indicate the building is under surveillance.

Ms. Butler said she is not moved by the argument of petty crime as a reason for the surveillance cameras and that it still comes down to the side of privacy and she also is not convinced that the videos do not fall under OPRA and will continue to vote against the ordinance.

Stormwater Ordinance Consolidation

Attached for introduction by Princeton Council, is a new stormwater ordinance which consolidates the former Borough Land Use Code Section 17A-193.1 and the former Township Land Use Code Section 10B-27, and revises the former Township Land Use Code sections 10B-246.1 and 10B-241 to be consistent with the consolidated ordinance. In addition to consolidating the two stormwater code sections, the following four major recommendations proposed by the Princeton Environmental Commission (PEC) and the Stony Brook-Millstone Watershed Association (SBMWA) are incorporated:

### 1. Minor Development Impervious Area Threshold

Former Township: In Section 10B-246.1 Table A, the former Township code regulates maximum permitted residential lot impervious coverage with and without stormwater management based on lot size. For lots ¼ acre or less, if the property owner can demonstrate that the runoff can be safely directed to a storm sewer or other suitable conveyance system, additional storm water management is not required. On lots larger than ¼ acre that exceed 500 square feet of new impervious coverage and are less than the maximum permitted impervious coverage in column A of the chart, storm water management is only required if the new impervious coverage cannot be adequately controlled and directly adversely impacts the adjoining property, at the discretion of the Municipal Engineer. There is a provision that allows the ability to increase the allowable impervious coverage by using the largest lot in the next smaller bracket in Table A.

**Borough:** In Section 17A-193.1, the former Borough requires storm water management for any increase in impervious coverage exceeding 400 square feet.

**Proposed:** Any increase in impervious coverage, exceeding 400 square feet, requires storm water management. (PEC is recommending the threshold for minor development be 250 square feet; this remains an open discussion item). Stormwater shall be retained onsite at a rate of 2 gallons for every square foot of new impervious coverage. It has to be shown that the overflow from the proposed stormwater management facility will not impact an adjacent property. If it is determined that the overflow from the proposed stormwater management facility will impact an adjacent property, then the stormwater must be retained onsite at a rate of 3 gallons for each square foot of new impervious coverage.

### 2. Major Development Thresholds

Former Township and Former Borough: Both of the former municipalities utilized the state standard thresholds for major developments of one (1) acre of disturbance or a ½-acre / 10,890 square feet of new impervious surface.

**Proposed:** The consolidated ordinance reduces the major development threshold to ½-acre of disturbance or 5,000 square feet of new impervious surface.

### 3. Impervious Surface Definition

**Former Township**: The former Township defined an impervious surface as "A surface that has been compacted or covered with a layer of material so that it is highly resistant to infiltration by water. Impervious surfaces include roofs and asphalt, concrete, and stone roads, parking lots, drives, sidewalks, and patios."

**Former Borough:** The former Borough defined an impervious surface as "A surface that has been compacted or covered with a layer of material so that it is highly resistant to infiltration by water. Impervious surfaces include roofs, asphalt, concrete, porous asphalt or concrete, gravel or stone, parking lots, drives, sidewalks, decks and patios."

<u>Proposed</u>: The consolidated ordinance proposes to define an impervious surface as "A surface that has been compacted and/or covered with a layer of material so that the surface is highly resistant to infiltration by water. Impervious surfaces include but are not limited to include roofs, asphalt, concrete, porous asphalt or concrete, gravel or stone parking lots, drives, or sidewalks, decks, pools and patios." This definition adds pools to the former Borough's impervious surface definition.

### 4. Inspection Permit Regulations

<u>Former Township and Former Borough</u>: Currently an inspection permit is not required by the former municipalities' codes.

**Proposed:** The consolidated ordinance proposes that any major development shall submit to the Engineering Department a yearly inspection report and an annual fee of \$50.00 in order to receive a stormwater management facility permit.

The following outstanding PEC / SBMWA stormwater ordinance recommendations will continue to be reviewed by the Engineering Department, and incorporated into an ordinance amendment if appropriate later this year:

- Stormwater management requirements for redevelopment sites.
- Inspection permit regulations for single family homes.
- Mitigation fee system for single family homes that cannot accommodate stormwater management facilities onsite.
