Mayor Trotman called the meeting to order at 12:00 noon and read **Agenda Item A, Call to Order and Open Public Meeting Act Statement** as follows:

"This meeting is called to order pursuant to the provisions of the Open Public Meetings Law. This meeting of January 6, 2008, advertised in the Trenton Times and Princeton Packet, posted on the bulletin board in the Borough of Princeton municipal building and has remained continuously posted as the required notices under the statute. In addition a copy of this notice is and has been available to the public and is on file of the Office of the Municipal Clerk. Proper notice having been given, the Municipal Clerk is directed to include this statement in the minutes of this meeting."

Mayor Trotman asked all present to rise for the salute to the flag.

Mayor Trotman acknowledged more than 40 years of support by "seventh council member," Charles St. John, who passed away in December 2007. She asked everyone to join her in a moment of silence commemorating Mr. St. John's life.

Mayor Trotman read **Agenda Item C, Public Presentation,** and asked if anyone present wished to address the Council with an item not on the agenda.

Martin Lombardo, Nassau Street, again asked Council to consider appointing a citizen police review board to assist Council in evaluating police powers and responsibilities. In particular, Mr. Lombardo questioned the need for two armed police forces in a town encompassing 1.8 square miles.

Seeing no one further from the public, Mayor Trotman closed the public presentation.

The Borough Clerk called the roll of the 2007 Borough Council.

Mayor Trotman took a moment to recognize distinguished visitors:

Mayor Trotman read Agenda Item E, Oath of Office for Mayor 2008 (four-year term).

Assemblywoman Bonnie Watson Coleman administered the oath of office while Mayor Trotman's son and grandson, Marvin Jr. and Marvin III, respectively held the bible.

Mayor Trotman read **Agenda Item F, Oaths of Office for Common Council 2008** (*three-year terms*).

Roger Martindell asked his son, Morgan, to hold the Bible while Mayor Trotman administered to him the oath of office for a three-year term on Common Council.

Councilman Martindell thanked Mayor, Council, and Borough voters for their support.

Andrew Koontz introduced his wife, Laurie Harmon, who held the Bible while Mayor Trotman administered to him the oath of office for a three-year term on Common Council.

COUNCILMAN ANDREW KOONTZ'S REORGANIZATION REMARKS

Thank you, Mayor Trotman and fellow Members of Council. I want to thank the voters of this wonderful community for again trusting me to serve on this Council.

Three years ago, when I was sworn in for my first full term, I talked about some of my priorities. I spoke about our neglected parks, and called for a commitment to do something for these important open spaces. I suggested then that a non-profit organization might be established to solicit funding, outside of tax revenue, for our parks.

We've come a long way. Most significantly, we have rehabilitated Pine Street Park, and are well underway with a complete overhaul of Potts Playground, thanks to a generous grant courtesy of County Executive Brian Hughes and the Mercer County Freeholders. A non-profit organization, the Princeton Parks Alliance, has matured into a strong advocate and fundraiser for our parks and has fulfilled another goal mentioned three years ago by Mayor Joseph O'Neill - the permanent illumination of the Princeton Battle Monument.

The coming year will bring new challenges, challenges that will require important decisions by this Council. First is the Harrison Street Park project. Last year, Council engaged a firm to develop design and construction documentation for the phased rehabilitation of this park. I am pleased to report that there has been significant progress, and the neighborhood has received the work done so far very well. In the coming months, we will consider the next phases of the work, which will certainly involve a commitment of capital. I look forward to working with my colleagues to move this exciting project forward. The second challenge I'd like to mention is the Recreation Master Plan. We will be receiving this plan in the coming year, and while it will demand many different decisions, I'd like to highlight one in particular. It is clear even in the data-gathering phase that there is a strong sentiment for our Recreation Department to be reformed as a full Parks and Recreation Department. We need to recognize that there is much more to this idea than simply changing a name. If we decide to pursue this goal, there will need to be comprehensive organizational changes that will include employees in municipalities, the make-up and purpose of the current Recreation Board, ordinance amendments, and many budgetary changes. Such a change will only be possible if the current thaw in the relationship between the Borough and the Township continues to hold. Let's also bear in mind that the department as it is constituted today does its job very well, and in those circumstances we should proceed with great caution. But recognizing all that, I support the concept of a Princeton Parks and Recreation Department as a way to better ensure the wise stewardship of all of our open spaces and look forward to working with my colleagues on this important issue.

The past 4 years on this Council has truly been a pleasure, and a lot of the reason for that goes to the entire Borough staff, but to two people especially, Bob Bruschi and Lea Quinty. I can't thank them enough. I'd like to thank all of my colleagues up here for putting up with me, especially my running mates, Mayor Trotman and Roger Martindell. Finally, I want to thank my wife, Laurie Harmon, for her constant help. God bless you all and have a wonderful 2008.

Mayor Trotman thanked residents James Floyd (Township) and Mark Freda for their active participation in local matters.

The Borough Clerk called the roll of the 2008 Borough Council.

Mayor Trotman read Agenda Item H, Election of Council President.

Councilwoman Benchley nominated Margaret T. Karcher for the office of Council President for 2008; Councilwoman Trelstad seconded. Borough Council approved the nomination unanimously.

Mrs. Karcher thanked her colleagues on Council for their support of her in the role of Council President. She also thanked Mayor Trotman for her tutelage, stating her loyalty to the mayor and support of the mayor's concerns. Council President Karcher addressed the relationship between Borough and Township. Recognizing the enthusiasm and warmth of Borough's relationship with its sister city in France and Township's relationship with its sister city in Italy, Council President Karcher noted that Borough shares borders with only the Township of Princeton. In every way possible, Borough and Township are closely tied together. Council President Karcher committed to lead a renewed effort in 2008 to establish a working rapport with Township.

CASH MANAGEMENT PLAN OF THE BOROUGH OF PRINCETON IN THE COUNTY OF MERCER, NEW JERSEY

I. STATEMENT OF PURPOSE

This Cash Management Plan (the "Plan" is prepared pursuant to the provision of N.J.S.A.40A:5-14 in order to set forth the basis for the deposits ("Deposits") and investment ("Permitted Investments") of certain public funds of the Borough of Princeton, pending the use of such funds for the intended purposes. The Plan is intended to assure that all public funds identified herein are deposited in interest bearing Deposits or otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made with regard to the Deposits and the Permitted Investments will be done to insure the safety, the liquidity, (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to insure that any Deposit or Permitted Investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments.

IDENTIFICATION OF FUNDS AND ACCOUNTS TO BE COVERED BY THE PLAN

A. The Plan is intended to cover the deposit and/or investment of the following funds and accounts of the Borough of Princeton:

Current Fund, Regular Trust Fund, Unemployment Trust Fund, Assessment Trust Fund, General Capital Fund, Affordable Housing Utility Fund, General Insurance Trust fund, Flexible Spending Trust Fund, Public Assistance Trust Fund, Law Enforcement Trust Fund, Landfill Closure Escrow Account, Open Space Tax Fund, Developer Escrow Fee Fund, Payroll Account, Zoning Planning Escrow Account, Parking Utility Operating Account and Parking Utility Capital Account, Grant Fund

B. It is understood that this plan is not intended to cover certain funds and accounts of the Borough of Princeton, specifically:

The following departments: Clerk, Municipal Court, Public Assistance Petty Cash Funds.

DESIGNATION OF OFFICIALS OF THE BOROUGH OF PRINCETON AUTHORIZED TO MAKE DEPOSITS AND INVESTMENTS UNDER THE PLAN.

The Chief Financial Officer of the Borough of Princeton and the Deputy Chief Financial Officer (the "Designated Official") are hereby authorized and directed to deposit and/or invest the funds referred to in the Plan. Prior to making any such deposits or any Permitted Investments, such officials of the Borough of Princeton are directed to supply to all depositories or any other parties with whom the deposits or Permitted investments are made a written copy of this Plan which shall be acknowledged in writing by such parties and a copy of such acknowledgement kept on file with such officials.

DESIGNATION OF DEPOSITORIES

The following banks and financial institutions are hereby designated as official depositories for the Deposit of all public funds referred to in the Plan, including any certificates of deposit which are not otherwise invested in Permitted Investments as provided for in this Plan:

PNC Bank – New Jersey, Bank of America, Wachovia Bank, Sovereign Bank, New Jersey Cash Management Fund, Chase Bank, Commerce Bank, **Bank of Princeton** and any other bank meeting the requirements of the Governmental Unit Deposit Protection Act, N.J.S.A. 17:9-41, et seq. ("GUDPA")

All such depositories shall acknowledge in writing receipt of this plan by sending a copy of such acknowledgment to the Designated Officials (s) referred to in Section III above.

V. AUTHORIZED INVESTMENTS

- A. Except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by this plan, to the extend not otherwise held in Deposits, in the following permitted investments:
- 1) Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America;
- Government Money Market Mutual Funds;
- 3) Any obligation that a federal agency or a federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor:
- 4) Bonds or other obligations of the local unit or bonds or other obligations of school districts of which the Local Unit is a part or within which the school district is located;
- 5) Bonds or other obligations, having maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of the Treasury for investment by local Units;
- Local government investment pools;
- 7) Deposits with the State of New Jersey Cash Management Fund established pursuant to section 1 of P.L. 1977, c.281 (C.52:18A-90.4); or
- 8) Agreements for the repurchase of fully collateralized securities if:
- (a) the underlying securities are permitted investments pursuant to paragraphs 1) and 3) of this subsection A;
- (b) the custody of collateral is transferred to a third party;
- (c) the maturity of the agreement is not more than 30 days;
- (d) the underlying securities are purchased through a pubic depository as defined in section 1 of P.L. 197-, c.236 (C.17:9-41); and
- (e) a master repurchase agreement providing for the custody and security of collateral is executed.

For the purposes of the above language, the terms "government money market mutual fund" and "local government investment pool" shall have the following definitions:

Government Money Market Mutual Fund

An investment company or investment trust:

- (a) which is registered with the Securities and Exchange Commission under the "Investment Company Act of 1940," 15 U.S.C. sec. 80a-1 et seq., and operated in accordance with 17 C.F.R. sec. 270. 2a-7.
- (b) the portfolio of which is limited to U.S. Government securities that meet the definition of any eligible security pursuant to 17 C.F.R. sec. 270. 2a-7 and repurchase agreements that are collateralized by such U.S. Government securities; and
- (c) which has:
- (i) attained the highest ranking or the highest letter and numerical rating of a nationally recognized statistical rating organization; or
- (ii) retained an investment advisor registered or exempt from registration with Securities and Exchange Commission pursuant to the "Investment Advisors Act of 1940," 15 U.S.C. sec. 80b-1 et seq., with experience investing in U.S. Government securities for at least the most recent past 60 months and with assets under management in excess of \$500 million.

Local Government Investment Pool

An investment pool:

- (a) which is managed in accordance with 17 C.F.R. sec. 270. 2a-7;
- (b) which is rated in the highest category by a nationally recognized statistical rating organization;
- (c) which is limited to U.S. Government securities that meet the definition of an eligible security pursuant to 17 C.F.R. sec. 270. 2a-7 and repurchase agreements that are collateralized by such U.S. Government securities;

- (d) which is in compliance with rules adopted pursuant to the "Administrative Procedure Act," P.L. 1968, c.410 (c.52:14B-1 et seq.) by the Local Finance Board of the Division of local Government Services in the Department of Community Affairs, which rules shall provide for disclosure and reporting requirements, and other provisions deemed necessary by the board to provide for the safety, liquidity and yield of the investments;
- (e) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions; cannot reasonably be expected, at the time of interest rate adjustment, to have a market value that approximates their par value; or utilize an index that does not support a stable net asset value; and
- (f) which purchases and redeems investments directly from the issuer, government money market mutual fund, or the state of New Jersey Cash Management Fund, or through the use of a national or State Bank located within this state, or through a broker-dealer which, at the time of purchase or redemption, has been registered continuously for a period of at least two years pursuant to section 9 of P.L. 1967 c.9 (c.49:3-56) and has at least \$25 million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits, or through a securities dealer who makes primary markets in U.S. Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government securities.
- B. Notwithstanding the above authorization, the monies on hand in the following funds and accounts shall be further limited as to maturities, specific investment or otherwise as follows:

 New Jersey Wastewater Treatment Trust Loan proceeds:

Interest earned may not exceed 7.238994%.

VI. CONFLICTS OF INTEREST

None of the Designated Official(s) listed in Section III above, or any governing body member of the Borough of Princeton has any conflict of interest with respect to the banks, financial institutions or brokerage firms listed in Sections IV above, except for the following:

VII. SAFEKEEPING, CUSTODY, PAYMENT AND ACKNOWLEDGMENT OF RECEIPT OF PLAN.

To the extent that any Deposit or Permitted Investment involves a document or security which is not physically held by the Borough of Princeton, then such instrument or security shall be covered by a custodial agreement with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investment in the name of the Borough of Princeton to assure that there is not unauthorized use of the funds or the Permitted Investments or Deposits. Purchase of any Permitted Investments that involve securities shall be executed by a "delivery versus payment" method to insure that such permitted Investments are either received by the Borough of Princeton or by a third party custodian prior to or upon the release of the Borough of Princeton's funds.

To assure that all parties with whom the Borough of Princeton deals with either by way of Deposits or Permitted Investment are aware of the authority and the limits set forth in this plan, all such parties shall be supplied with a copy of this Plan in writing and all such parties shall acknowledge the receipt of that plan in writing, a copy of which shall be on file with the Designated Official(s).

VIII. <u>REPORTING REQUIREMENTS.</u>

On the first day of each month during which this Plan is in effect, the Designated Official(s) referred to in Section III hereof shall supply to the governing body of the Borough of Princeton a written report of any Deposits or Permitted Investments made pursuant to this Plan, which shall include, at a minimum, the following information:

- A. The name of any institution holding funds of the Borough of Princeton as a Deposit or a Permitted Investment.
- B. The amount of securities or Deposits purchased or sold during the immediately preceding month.
- C. The Class of type of securities purchased or Deposits made.
- D. The book value of such Deposits or Permitted Investments.
- E. The earned income on such Deposits or Permitted Investments. To the extent that such amounts are actually earned at maturity, this report shall provide an accrual of such earnings during the immediately preceding month.

- F. The fees incurred to undertake such Deposits or Permitted Investments.
- G. The market value of all Deposits or Permitted Investments as of the end of the immediately preceding month.
- H. All other information which may be deemed reasonable from time to time by the governing body of the Borough of Princeton.

IX. TERM OF PLAN

This plan shall be in effect from January 1, 2008 to December 31, 2008. Included with this plan is a resolution of the governing body of the Borough of Princeton approving this Plan for such period of time. The Plan may be amended from time to time to the extent that any amendment is adopted by the governing body of the Borough of Princeton, the Designated Official is directed to supply copies of the amendment to all of the parties who otherwise have received the copy of the originally approved Plan, which amendment shall be acknowledged in writing in the same manner as the original Plan was so acknowledged.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Princeton that the Chief Financial Officer of the Borough of Princeton is hereby authorized on behalf of said Borough to execute, sell and deliver obligations in accordance with the New Jersey Local Bond Law during 2008.

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to the Chief Financial Officer and the Municipal Clerk.

RESOLUTION 2008-R27

OF THE MAYOR AND COUNCIL OF THE BOROUGH OF PRINCETON AUTHORIZING THE TAX ASSESSOR TO FILE APPEALS ON BEHALF OF THE BOROUGH OF PRINCETON IN CONJUNCTION WITH THE BOROUGH ATTORNEY'S OFFICE

WHEREAS, the Borough of Princeton on occasion must file tax appeals; and

WHEREAS, under State Statute N.J.S.A. 54:3-21, a Tax Assessor can only file the appeal on behalf of the municipality if authorized by resolution to do so; and

WHEREAS, the Mayor and Council of the Borough of Princeton has determined that it is in the Borough's best interest for the Tax Assessor to file the necessary documents.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Princeton that Neal Snyder, Borough Tax Assessor, be and hereby is authorized to file appeals on behalf of the Borough of Princeton in conjunction with the Borough Attorney's office.

WHEREAS, twenty-six and one quarter percent of the total appropriations in the 2007 budget, exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund and public assistance in said 2007 budget is the sum of \$5,175,330.00

NOW, THEREFORE, BE IT RESOLVED that the following appropriations be made attached hereto and that a certified copy of this resolution be transmitted to the Chief Financial Officer and Division of Local Government Services for their records;

Councilman Goldfarb moved to approve Resolution 2008-R28, seconded by Council President Karcher. Mayor Trotman called for a roll call vote. Borough Clerk called the roll. Council members Karcher, Benchley, Goldfarb, Koontz, Martindell, and Trelstad voted in the affirmative. Mayor Trotman proclaimed the resolution approved.

WHEREAS, twenty-six and one quarter percent of the total appropriations in the 2007 budget, exclusive of any appropriations made for interest and debt redemption charges in said 2007 budget is the sum of \$25,676.00

NOW, THEREFORE, BE IT RESOLVED that the following appropriations be made attached hereto and that a certified copy of this resolution be transmitted to the Chief Financial Officer and Division of Local Government Services for their records;

Councilman Goldfarb moved to approve Resolution 2008-R29, seconded by Council President Karcher. Mayor Trotman called for a roll call vote. Borough Clerk called the roll. Council Members Karcher, Benchley, Goldfarb, Koontz, Martindell, and Trelstad voted in the affirmative. Mayor Trotman proclaimed the resolution approved.

Mayor Trotman read **Agenda Item I, New Business (30) — Resolution 2008-R30** as follows:

RESOLUTION 2008-R30 OF THE MAYOR AND COUNCIL OF THE BOROUGH OF PRINCETON APPROVING THE PARKING UTILITY OPERATING TEMPORARY BUDGET FOR 2008

WHEREAS, N.J.S.A. 40A:4-19 provides that where any contract, commitment or payments are to be made prior to the final adoption of the 2008 budget, temporary appropriations should be made for the purpose and amounts required in the manner and time therein provided: and

WHEREAS, the date as this resolution is within the first thirty days of January 2008 and;

WHEREAS, the total appropriations in the 2008 budget, exclusive of any appropriations made for interest and debt redemption charges, is the sum of \$350,000.00

WHEREAS, twenty-six and one quarter percent of the total appropriations in the 2007 budget, exclusive of any appropriations made for interest and debt redemption charges in said 2007 budget is the sum of \$573,924.00

NOW, THEREFORE, BE IT RESOLVED that the following appropriations be made attached hereto and that a certified copy of this resolution be transmitted to the Chief Financial Officer and Division of Local Government Services for their records:

Councilman Koontz moved to approve Resolution 2008-R30, seconded by Councilwoman Benchley. Mayor Trotman called for a roll call vote. Borough Clerk called the roll. Council Members Karcher, Benchley, Goldfarb, Koontz, Martindell, and Trelstad voted in the affirmative. Mayor Trotman proclaimed the resolution approved.

Mayor Trotman read **Agenda Item J — Mayor's Annual Address.**

During her annual address, Mayor Trotman thanked the guests for attending, thanked Council members for their support, emphasized the importance of help from volunteers, and mentioned Mr. Peters's enormous contribution during his 24 years of service as Borough Engineer. Mayor Trotman listed accomplishments of 2007 and plans for 2008.

Mayor's Address 1-6-08

Mildred T. Trotman

Happy New Year to all of you and thank you for joining us today. To Council, thank you for the support you've given me this past year. Together we will continue to work to make Princeton Borough the best it can be for all of us. To all the volunteers, without whom we simply could not exist and function as we try to keep Princeton Borough inviting to all who live, work, and visit in Princeton, THANK YOU, THANK YOU, THANK YOU. Elected officials are often the ones who

are congratulated on jobs well done — we know but for the enormous amount of talent, knowledge, experience, and energy spent by the volunteers year after year Princeton would not function as well as it does, nor survive without paying the price financially for the same services that we are so fortunate to get from our volunteers. You bring your skills and expertise to the many difficult issues and tasks we face and we are all the better for your addition. Thank you hardly seems adequate, but it is sincerely meant.

2007 was a productive year for us.

- For the 3rd year in a row, we kept the budget under 5% (an average of 3.2%), and we did that while, 1) maintaining the health, welfare, and safety of our residents, which is the responsibility of M/C, 2) without depleting our reserves, and 3) not increasing our workforce.
- We received approximately \$200,000 in Grant money in our continuous effort to give the taxpayer as much relief as possible.
- We have maintained the quality and level of service to our citizenry without increasing our workforce, except police department which I will talk about a bit later.
- We launched a new web site for which we received Honorable Mention (only three weeks after launch) from the NJ League of Municipalities in the 46th Annual Municipal Public Information Contest.
- We passed the Stormwater Ordinance.
- We instituted the Volunteer Fire Department Incentive Program.
- We completed the Potts Park Renovation.
- We reorganized our Engineering and SOC offices after the retirement of Mr. Peters, our Engineer who served the Borough for some 24 years.
- The pergola was installed.
- We partnered with the Mercer County Board of Freeholders in a Polling Place Accessibility Grant and used the
 proceeds for handicapped accessible doors at the Hook and Ladder Firehouse, and automatic swing door entry at the
 Suzanne Paterson Senior Center.
- We continued our community relationships with our neighbors in town
 and when necessary reaching out across the borders to the State and Mercer County when we have Jazzfeast,
 Communiversity, hang banners along Nassau Street, work with the Spirit of Princeton during one of their many
 activities each year, and continue our positive relationship with the Borough Merchants.
- In April, 2007, to the delight of many, the Albert E. Hinds Memorial Plaza was officially approved by M/C recognizing the life and history of one of Princeton's finest who died at the age of 104 in April, 2006.
- In June the Supreme Court ruled in favor of the Cottage Club being a certified historic site meaning it qualified for tax-exempt status; however, soon after the Legislature voted in favor of a bill that would create specific regulatory mandates on private clubs such that the Cottage Club would not qualify. We want to thank our legislative Representatives for all their support in this endeavor. That decision by the Legislature may be challenged by the Cottage Club. Stay tuned.
- In September, 2007, the lighting of the Princeton Battle Monument was celebrated by many, including Anne O'Neill who came back to Princeton to witness the dream of her late husband, Mayor Joe O'Neill, who had begun the process of raising funds for the necessary money to light the monument. Thank you to Princeton Parks Alliance, spearheaded by Andrew Koontz, for picking up this project and seeing it through to its fruition.
- Early on in the year the Princetons were given a \$60,000 Grant from the NJ Municipal Land Use Center at TCNJ. A Steering Committee made up of Princeton Twp. and Princeton Borough residents, and representatives from throughout the community was formed with a mission to help make Princeton a sustainable community. I was a signatory to the U.S. Mayors Climate Protection Agreement to further promote this mission. Citizen involvement has been quite positive and we will continue to encourage residents to respect the environment, live healthier lifestyles, and be more creative in sustaining our community.
- We adopted the Princeton Borough Crosswalk Improvement Plan (funded by a Grant from NJDOT) in November, 2007, recognizing the importance of effective pedestrian crossings to the overall walking environment, and because Princeton Borough is one of the most pedestrian-oriented environments in New Jersey. Thank you to the Traffic and Transportation Committee and others who worked on this.
- During 2007 we had the opportunity to continue discussions with NJDOT on issues of concern to all of us, most notably in 2007 the New Jersey Access Network Exclusion Request, Routes 206 and 27. We will continue to press for relief from the trucks that traverse our roadways through our residential/historic districts, on roadways too narrow to pull the trucks over for violations. We do appreciate all the support from our legislative representatives on our behalf in this endeavor. While I am not as optimistic about the outcome as I once was, we will continue the effort and the Commissioner did leave the door open to some compromise.
- We have been informed that the shuttle vehicle promised Princeton
 Borough will not be available until July, 2008. In discussions with the
 University they indicated a desire to explore the potential for helping the
 Borough get started prior to receiving the vehicle from New Jersey
 Transit a trial run if you will. This would also allow the Borough to
 work out any kinks in the operation of running a shuttle/jitney system.
 We certainly plan to follow up on that.

Unfortunately, we did not begin Building C of the Redevelopment Project; the Arts Council did not move back to 102 Witherspoon Street; we did not finalize the zoning for the Merwick tract; and Hullfish North has put off groundbreaking of its project until later this month. However, there is every reason to be optimistic that all projects will take place sometime during the beginning of this year.

I mentioned earlier that we had increased the number of staff in the police department, we added two officers. I feel this was necessary to make sure that Princeton Borough is as safe as it can possibly be, and is in a position to be as pro-active, and as anticipatory of events as it can possibly be. Those officers will properly staff a new Community Services Unit which will provide community based pro-active policing. This unit will support the regular patrol force by conducting bicycle patrols, traffic enforcement and foot patrol duties throughout our community, and conduct greater community youth outreach in an effort to help prevent illegal gang activities in our community.

2008 will have its challenges as does every other year. We will be faced with the new State Budget Law which does not permit municipal taxes to be increased more than 4%. We will have to work with the new numbers from COAH's 3rd round; we have the PBA Labor Agreement to negotiate; we have already begun the revaluation process, the specs are complete to be sent out to the state approved bidders with inspections to commence throughout the year, and property owners should receive a new assessment notice in the fall.

WE will continue to set policy that we feel is in the best interest of Princeton Borough, and prioritize the issues in a way that is fair and balanced to all.

WE will continue to try to find ways to work with our business community and downtown stakeholders to make this an all inclusive community where everyone is heard. There is much work to be done and I will do everything within my power to improve the quality of life for all of our residents.

In closing, let me say every year we are required to do more with less, do more with less, and every year we meet that requirement. How long can we continue to do that? I don't have the answer, but I will tell you that we will continue to try and I am optimistic that we will succeed.

It is an honor and privilege to represent you and as I look forward to the challenges ahead, I take this opportunity to remind you that the more input we as elected representatives get from you, the better the end result. I look forward to working with all of you in 2008.

Thank you to the staff for continuing to work with me as we strive to serve Princeton Borough. Best wishes to all of you for a Healthy and Happy New Year. Please join us at the firehouse on Witherspoon Street for food and festive conversation
