Mayor Trotman called the meeting to order at 7:37 P.M. and read the open public meetings statement as follows:

"This meeting is called to order pursuant to the provisions of the Open Public Meetings Law. This meeting of January 22, 2008, was included in a list of meetings sent to and advertised in the Princeton Packet and Trenton Times, posted on the bulletin board in the Borough of Princeton municipal building and has remained continuously posted as the required notices under the statute. In addition a copy of this notice is and has been available to the public and is on file in the Office of the Borough Clerk. Proper notice having been given, the Borough Clerk is directed to include this statement in the minutes of this meeting,"

Mayor Trotman read **Agenda Item C, Resolution 2008-R42** as follows:

RESOLUTION 2008-R42 OF THE MAYOR AND COUNCIL OF THE BOROUGH OF PRINCETON INTO CLOSED SESSION ON JANAURY 22, 2008

WHEREAS, the Open Public Meetings Act, P.L. 1975, Chapter 231 permits the exclusion of the public forum from a meeting in certain circumstances; and

WHEREAS, this public body is of the opinion that such circumstances may presently exist; and WHEREAS, the Governing Body wishes to discuss the following issues:

- 1. Negotiations NHKT
- 2. Closed session minutes August 7, 2007
- 3. Library parking
- 4. Northridge

WHEREAS, minutes will be kept and once the matter involving confidentiality of the above no longer requires that confidentiality, then minutes can be made public; and

NOW THEREFORE BE IT RESOLVED that the public be excluded from this meeting.

Council President Karcher moved to approve, which was seconded by Councilman Goldfarb and approved by Council members Karcher, Goldfarb, Koontz, Martindell, and Trelstad. Hearing no nay votes, Mayor Trotman proclaimed the resolution approved.

Borough Council recessed into closed session.

At 7:37 P.M. the Council reconvened into open session.

Mayor Trotman asked all present to rise for the salute to the flag.

Mayor Trotman read Agenda Item E, Approval of Minutes.

Presented for approval were the minutes of the closed session of August 7, 2007.

Councilwoman Trelstad moved to approve the minutes of the closed session of August 7, 2007; Councilman Goldfarb seconded.

Councilman Martindell pointed out that these minutes refer to offers tendered to NHKT but do not indicate the written offer. He moved to amend the minutes to attach details. Hearing no second, Mayor Trotman proclaimed the motion failed.

Mayor Trotman reminded Council of the motion to approve the minutes as they stand, excepting that Councilman Koontz be listed as absent for the closed session. Mayor Trotman called for a vote and proclaimed the motion passed three to one, with Councilman Martindell voting nay and Council members Benchley and Koontz abstaining.

Councilman Martindell moved to release immediately to the public the minutes of the closed session of August 7, 2007, as approved. Hearing no second, Mayor Trotman proclaimed the motion failed. For the record, Mayor Trotman announced that the minutes be released to the public at some time in the future.

Presented for approval were the minutes of the reorganization meeting of January 6, 2008.

Councilman Koontz moved to approve the minutes of the reorganization meeting January 6, 2008; Councilman Martindell seconded; Council approved unanimously.

Mayor Trotman read **Agenda Item F, Summary — Closed Session Discussion —** Robert W. Bruschi, Borough Administrator

Borough Administrator Robert Bruschi summarized that Council reviewed NHKT negotiation positions in anticipation of presenting Borough's concerns to NHKT.

Mayor Trotman read **Agenda Item G, Public Presentation,** and asked if anyone present wished to address the Council with an issue not on the agenda.

Henry Landau, owner of Landau's on Nassau Street, reminded Council of a construction trailer with nearby fencing sections on Tulane lot that he had mentioned previously at an October Council meeting. Mr. Landau stated that Council has cost Borough taxpayers nearly \$18,000 over three years by forfeiting the two parking spaces where the trailer sits. Mr. Landau also stated the Borough-owned Tulane lot has not been paved in more than 30 years, and the lighting is totally inadequate.

Mr. Landau also asked about the status of water in the municipal garage basement; the value of five-year-old dollar basis for payment in lieu of tax [PILOT] calculations compared to today's dollars; and other checklist items including hanging wires near Community Liquors, garbage receptacles, and rusting light poles.

Councilman Martindell asked Mr. Bruschi for the cost to date to repair design flaws in the garage.

Seeing no one further from the public, Mayor Trotman closed the public portion.

Mayor Trotman read **Agenda Item H, Report (1) — Monthly Police Report —** *Anthony Federico, Chief of Police*

RESOLUTION 2008-R43 OF THE MAYOR AND COUNCIL OF THE BOROUGH OF PRINCETON APPROVING THE MONTHLY CHIEF OF POLICE REPORT

WHEREAS, Anthony V. Federico, Chief of Police of the Borough of Princeton prepared a comprehensive report detailing the police activity for the month of November 2007; and

WHEREAS, the Mayor and Council reviewed said report at their Regular Meeting attended by Chief of Police Federico and made various inquiries of Chief Federico.

NOW THEREFORE BE IT RESOLVED that the Mayor and Council hereby accept the November 2007 Monthly police report prepared by the Chief of Police.

Chief Federico pointed to reported response training for police reaction to a calamity at a school explaining that 360 hours of training was condensed over two days for all patrol officers and detectives.

Councilwoman Benchley asked Chief Federico for an overview of responsibilities of the two new officers as of January 1, 2008. Chief Federico responded that tasks will include traffic and neighborhood patrol (primarily evening hours). Currently they are updating the merchant alert plan for shoplifting and robbery measures; participating in the Stop Underage Drinking program at liquor stores; and plain clothes details for alcohol and drug possession. Radar patrol will be part of their everyday duty. Chief Federico stated that Borough has reached out to Princeton Township for a joint effort to cite speeding trucks on Route 206.

Chief Federico clarified some line item activities in the November 2007 report such as disorderly conduct and harassment, false fire alarms, and jaywalking and cell phone enforcement.

Councilman Koontz moved to approve Resolution 2008-R43, Councilwoman Benchley seconded, and Borough Council approved unanimously.

Mayor Trotman asked Councils approval and read, out of sequence, **Agenda Item J, New Business (9)** — **Resolution 2008-R44** as follows:

RESOLUTION 2008-R44 OF THE MAYOR AND COUNCIL OF THE BOROUGH OF PRINCETON AUTHORIZING EXECUTION OF AGREEMENTS PRINCETON COMMUNITY HOUSING

WHEREAS, by Ordinance No. 2006-24, the Mayor and Council of the Borough of Princeton authorized the conveyance of the real property upon which certain affordable housing is located known as Elm Court and Harriet Bryan House (Block 1.01, Lot 4.01 on the tax map of the Borough of Princeton and Block 6501, Lot 1.10 on the tax map of the Township of Princeton, hereinafter the "Property") to Elm Court, I., Inc. and Elm Court, II., Inc. respectively, which were created by Princeton Community Housing who had advised that they were single asset 501 (c) 3 non-profit corporations whose purpose was to construct housing for low and moderate income persons or families and handicapped persons; and

WHEREAS, Elm Court I, Inc. and Elm Court, II, Inc. have received the necessary subdivision approvals to allow such conveyance; and

WHEREAS, Princeton Community Housing has advised that it now wishes to take title to those lands upon which Elm Court is located (Block 1.10, Lot 4.01) in the name of a different corporate entity known as Elm Court, Inc., rather than Elm Court I, Inc. as previously approved by the Mayor and Council; and

WHEREAS, Princeton Community Housing has further advised that Elm Court, Inc. is a non-profit entity which has received approval as a public charity within Section 509 (a) (2) of the Internal Revenue Code, said approval being subject to conveyance by the Borough of the lands upon which Elm Court is located; and

WHEREAS, Princeton Community Housing has also requested that in connection with the conveyance of title that the Borough execute agreements attached hereto terminating the existing land leases on the Property between the Borough and Princeton Community Housing as well as providing for certain payments in lieu of taxes on the Elm Court project (Block 1.01, Lot 4.01) and on that portion of the Harriet Bryan Housing property located in the Borough of Princeton, known as Block 1.01, Lot 4.02, on which 12 housing units are located, for a 50 year period subject compliance with the terms of the tax abatement agreements; and

WHEREAS, in connection with the conveyance of title, the Borough and Princeton Community Housing also wish to terminate a portion of an existing driveway access easement, as set forth in the attached agreement;

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Princeton as follows:

The Mayor and Clerk are authorized to execute the following documents, attached hereto: (1.) Termination of Lease Agreement between Borough of Princeton and Elm Court II, Inc; (2.) Termination of Lease Agreement between Borough of Princeton, Elm Court, Inc. and Princeton Community Housing, Inc."; (3.) Termination of Portion of Driveway Access Easement; (4.) Tax Abatement Agreement between Borough of Princeton and Elm Court, Inc. (5.) Tax Abatement Agreement between Borough of Princeton and Elm Court II, Inc.

BE IT FURTHER RESOLVED that the Mayor and Clerk are authorized to execute a deed and related documents necessary to transfer Block 1.01, Lot 4.01 as located on the tax map of the Borough of Princeton, to Elm Court, Inc. subject to all reverter provisions previously set forth in Borough Ordinance 2006-24.

Councilman Koontz moved to approve Resolution 2008-R44, and Councilwoman Trelstad seconded. Borough Attorney Karen Cayci explained that Mayor and Council had agreed to transfer Elm Court I and II properties for subdivision. Documents of conveyance are now ready and Council needs to pass a resolution in order to continue receiving PILOT funds. Borough Council approved unanimously.

Councilman Goldfarb clarified that the three superior officers will rise one step per year for the duration of the contract, resulting in actual increases of more than five percent compounded. Councilman Martindell added the impact of economic recession on Borough taxpayers. Councilwoman Benchley agreed that Council is "trapped" by arbitration tactics. Councilwoman Trelstad pressed for consolidation with the Township as a route to lower police costs.

- 1. The contract so authorized shall require the Provider to provide services and other related duties, as follows:
- (a) Provide Healthy Child/Well Baby nursing services for uninsured residents of the municipalities of Princeton Borough and Township for the promotion of health and prevention of chronic and communicable diseases, to perform physical examination, growth measurements, required immunizations, tuberculin tests lead, vision, anemia and hearing screenings and developmental assessment as listed in the attached professional services agreement.

The Mayor and Clerk are hereby authorized to enter into a contract for the professional services with THE MEDICAL CENTER OF PRINCETON "THE CENTER" (hereinafter referred to as "The Provider") to provide services from January 1, 2008 through December 31, 2008.

- 1. The contract so authorized shall require the Provider to provide services and other related duties, as follows:
- (a) Provide a qualified health practitioner to perform physical examination of patients and their contacts in order to diagnose sexually transmitted disease;
- (b) Provide qualified professional advanced practice nurses to manage the service in accordance with the policies and regulations of the Center:
- (c) Provide all interviewing of patients diagnosed with sexually transmitted disease. The interviewer shall be appropriately trained for this task;
 - (d) Provide adequate laboratory services for bacteriologic and serologic analyses;
- (e) Provide diagnostic and treatment facilities which are accessible to the public on an appointment basis.
- (f) Provide an appropriate treatment for persons diagnosed as having sexually transmitted diseases. Such treatment shall be administered according to N.J. State Department of Health guidelines and generally accepted medical practice.
- 2. The Center shall provide the Health Officer with a written monthly report in a format approved by the Commission.
- 3. The Center shall provide a written annual report summarizing the activities of the program.
- 4. The Center shall immediately notify the Health Officer of all positive diagnosis of disease for follow-up by the Health Officer or his designee for examination during regular business hours.
- 5. The clinical records of the Center shall be accessible to the Health Officer or his designee for examination during regular business hours.
- 6. The services provided by the Center shall be performed under the specific direction and periodic supervision of the Center's Director of the Outpatient Clinics/Department of Medicine, who shall

periodically consult and confer with the Commission's Health Officer.
