WHEREAS, N.J.S.A. 40A:5-14 requires that the governing body must approve, by a majority vote, an annual cash management plan,

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Princeton that the Cash Management Plan, attached hereto, is hereby approved for the calendar year 2009 and that the Chief Financial Officer is directed to implement said Cash Management Plan in accordance with all applicable statutes.

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to the Chief Financial Officer and the Municipal Clerk.

CASH MANAGEMENT PLAN OF THE BOROUGH OF PRINCETON IN THE COUNTY OF MERCER, NEW JERSEY

I. STATEMENT OF PURPOSE

This Cash Management Plan (the "Plan" is prepared pursuant to the provision of N.J.S.A.40A:5-14 in order to set forth the basis for the deposits ("Deposits") and investment ("Permitted Investments") of certain public funds of the Borough of Princeton, pending the use of such funds for the intended purposes. The Plan is intended to assure that all public funds identified herein are deposited in interest bearing Deposits or otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made with regard to the Deposits and the Permitted Investments will be done to insure the safety, the liquidity, (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to insure that any Deposit or Permitted Investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments.

IDENTIFICATION OF FUNDS AND ACCOUNTS TO BE COVERED BY THE PLAN

A. The Plan is intended to cover the deposit and/or investment of the following funds and accounts of the Borough of Princeton:

Current Fund, Regular Trust Fund, Unemployment Trust Fund, Assessment Trust Fund, General Capital Fund, Affordable Housing Utility Fund, General Insurance Trust fund, Flexible Spending Trust Fund, Public Assistance Trust Fund, Law Enforcement Trust Fund, Landfill Closure Escrow Account, Open Space Tax Fund, Developer Escrow Fee Fund, Payroll Account, Zoning Planning Escrow Account, Parking Utility Operating Account and Parking Utility Capital Account, Grant Fund

B. It is understood that this plan is not intended to cover certain funds and accounts of the Borough of Princeton, specifically:

The following departments: Clerk, Municipal Court, Public Assistance Petty Cash Funds.

DESIGNATION OF OFFICIALS OF THE BOROUGH OF PRINCETON AUTHORIZED TO MAKE DEPOSITS AND INVESTMENTS UNDER THE PLAN.

The Chief Financial Officer of the Borough of Princeton and the Deputy Chief Financial Officer (the "Designated Official") are hereby authorized and directed to deposit and/or invest the funds referred to in the Plan. Prior to making any such deposits or any Permitted Investments, such officials of the Borough of Princeton are directed to supply to all depositories or any other parties with whom the deposits or Permitted investments are made a written copy of this Plan which shall be acknowledged in writing by such parties and a copy of such acknowledgement kept on file with such officials.

DESIGNATION OF DEPOSITORIES

The following banks and financial institutions are hereby designated as official depositories for the Deposit of all public funds referred to in the Plan, including any certificates of deposit which are not otherwise invested in Permitted Investments as provided for in this Plan:

PNC Bank – New Jersey, Bank of America, Wachovia Bank, Sovereign Bank, New Jersey Cash Management Fund, Chase Bank, Commerce Bank, **Bank of Princeton** and any other bank meeting the requirements of the Governmental Unit Deposit Protection Act, N.J.S.A. 17:9-41, et seq. ("GUDPA")

All such depositories shall acknowledge in writing receipt of this plan by sending a copy of such acknowledgment to the Designated Officials (s) referred to in Section III above.

V. AUTHORIZED INVESTMENTS

A. Except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by this plan, to the extend not otherwise held in Deposits, in the following permitted investments:

- 1) Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America;
 - 2) Government Money Market Mutual Funds;
- 3) Any obligation that a federal agency or a federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor;
- 4) Bonds or other obligations of the local unit or bonds or other obligations of school districts of which the Local Unit is a part or within which the school district is located;
- 5) Bonds or other obligations, having maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of the Treasury for investment by local Units;
 - 6) Local government investment pools;
- 7) Deposits with the State of New Jersey Cash Management Fund established pursuant to section 1 of P.L. 1977, c.281 (C.52:18A-90.4); or
 - 8) Agreements for the repurchase of fully collateralized securities if:
- (a) the underlying securities are permitted investments pursuant to paragraphs 1) and 3) of this subsection A;
 - (b) the custody of collateral is transferred to a third party;
 - (c) the maturity of the agreement is not more than 30 days;
- (d) the underlying securities are purchased through a pubic depository as defined in section 1 of P.L. 197-, c.236 (C.17:9-41); and
- (e) a master repurchase agreement providing for the custody and security of collateral is executed.

For the purposes of the above language, the terms "government money market mutual fund" and "local government investment pool" shall have the following definitions:

Government Money Market Mutual Fund

An investment company or investment trust:

- (a) which is registered with the Securities and Exchange Commission under the "Investment Company Act of 1940," 15 U.S.C. sec. 80a-1 et seq., and operated in accordance with 17 C.F.R. sec. 270. 2a-7.
- (b) the portfolio of which is limited to U.S. Government securities that meet the definition of any eligible security pursuant to 17 C.F.R. sec. 270. 2a-7 and repurchase agreements that are collateralized by such U.S. Government securities; and
 - (c) which has:
- (i) attained the highest ranking or the highest letter and numerical rating of a nationally recognized statistical rating organization; or
- (ii) retained an investment advisor registered or exempt from registration with Securities and Exchange Commission pursuant to the "Investment Advisors Act of 1940," 15 U.S.C. sec. 80b-1 et seq., with experience investing in U.S. Government securities for at least the most recent past 60 months and with assets under management in excess of \$500 million.

Local Government Investment Pool

An investment pool:

- (a) which is managed in accordance with 17 C.F.R. sec. 270. 2a-7;
- (b) which is rated in the highest category by a nationally recognized statistical rating organization;
- (c) which is limited to U.S. Government securities that meet the definition of an eligible security pursuant to 17 C.F.R. sec. 270. 2a-7 and repurchase agreements that are collateralized by such U.S. Government securities;
- (d) which is in compliance with rules adopted pursuant to the "Administrative Procedure Act," P.L. 1968, c.410 (c.52:14B-1 et seq.) by the Local Finance Board of the Division of local Government Services in the Department of Community Affairs, which rules shall provide for disclosure and reporting requirements, and other provisions deemed necessary by the board to provide for the safety, liquidity and yield of the investments;
- (e) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions; cannot reasonably be expected, at the time of interest rate adjustment, to have a market value that approximates their par value; or utilize an index that does not support a stable net asset value; and
- (f) which purchases and redeems investments directly from the issuer, government money market mutual fund, or the state of New Jersey Cash Management Fund, or through the use of a national or State Bank located within this state, or through a broker-dealer which, at the time of purchase or redemption, has been registered continuously for a period of at least two years pursuant to section 9 of P.L. 1967 c.9 (c.49:3-56) and has at least \$25

million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits, or through a securities dealer who makes primary markets in U.S. Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government securities.

B. Notwithstanding the above authorization, the monies on hand in the following funds and accounts shall be further limited as to maturities, specific investment or otherwise as follows:

New Jersey Wastewater Treatment Trust Loan proceeds: Interest earned may not exceed 7.238994%.

VI. CONFLICTS OF INTEREST

None of the Designated Official(s) listed in Section III above, or any governing body member of the Borough of Princeton has any conflict of interest with respect to the banks, financial institutions or brokerage firms listed in Sections IV above, except for the following:

VII. SAFEKEEPING, CUSTODY, PAYMENT AND ACKNOWLEDGMENT OF RECEIPT OF PLAN.

To the extent that any Deposit or Permitted Investment involves a document or security which is not physically held by the Borough of Princeton, then such instrument or security shall be covered by a custodial agreement with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investment in the name of the Borough of Princeton to assure that there is not unauthorized use of the funds or the Permitted Investments or Deposits. Purchase of any Permitted Investments that involve securities shall be executed by a "delivery versus payment" method to insure that such permitted Investments are either received by the Borough of Princeton or by a third party custodian prior to or upon the release of the Borough of Princeton's funds.

To assure that all parties with whom the Borough of Princeton deals with either by way of Deposits or Permitted Investment are aware of the authority and the limits set forth in this plan, all such parties shall be supplied with a copy of this Plan in writing and all such parties shall acknowledge the receipt of that plan in writing, a copy of which shall be on file with the Designated Official(s).

VIII. REPORTING REQUIREMENTS.

On the first day of each month during which this Plan is in effect, the Designated Official(s) referred to in Section III hereof shall supply to the governing body of the Borough of Princeton a written report of any Deposits or Permitted Investments made pursuant to this Plan, which shall include, at a minimum, the following information:

- A. The name of any institution holding funds of the Borough of Princeton as a Deposit or a Permitted Investment.
- B. The amount of securities or Deposits purchased or sold during the immediately preceding month.
- C. The Class of type of securities purchased or Deposits made.
- D. The book value of such Deposits or Permitted Investments.
- E. The earned income on such Deposits or Permitted Investments. To the extent that such amounts are actually earned at maturity, this report shall provide an accrual of such earnings during the immediately preceding month.
- F. The fees incurred to undertake such Deposits or Permitted Investments.
- G. The market value of all Deposits or Permitted Investments as of the end of the immediately preceding month.
- H. All other information which may be deemed reasonable from time to time by the governing body of the Borough of Princeton.

IX. TERM OF PLAN

This plan shall be in effect from January 1, 2009 to December 31, 2009. Included with this plan is a resolution of the governing body of the Borough of Princeton approving this Plan for such period of time. The Plan may be amended from time to time to the extent that any amendment is adopted by the governing body of the Borough of Princeton, the Designated Official is directed to supply copies of the amendment to all of the parties who otherwise have received the copy of the originally approved Plan, which amendment shall be acknowledged in writing in the same manner as the original Plan was so acknowledged.

Councilwoman Karcher moved to approve Resolution 2009-R27; Councilwoman Trelstad seconded. Hearing no discussion, Mayor Trotman called for a roll call vote. Borough Clerk called the roll. Council members Koontz, Goldfarb, Karcher, Martindell, Trelstad, and Wilkes voted in the affirmative. Mayor Trotman proclaimed the resolution approved.

During her annual address, Mayor Trotman thanked Council for support during 2008 and promised citizens that she and Council will work to achieve the best Borough of Princeton possible.

Mayor's Annual Address Mildred Trotman January 4, 2009

Happy New Year to all of you, and thank you for joining us today. Once again, it is my pleasure to thank you, Council, for the support you've given me this past year, and to say to Princeton Borough residents--- together we will continue to work to make Princeton Borough the best it can be for all of us.

Though I have said this before, I would be totally remiss if I did not take this opportunity to thank all of the volunteers who give so generously of their time and talent to help us make informed decisions so that the policy we set will be in the best interest of all Princeton Borough residents. The expertise and experience from our volunteers help guide us in shaping the decisions that are needed to preserve what we think Princeton Borough represents. **THANK YOU - THANK YOU.**

In spite of the difficult economic times, the uncertainties of the future, the mortgage crisis, the bail outs the government has had to make, the cut backs on every level - federal, state, county -, 2008 was a productive year for Princeton Borough overall.

- For the 4th year in a row, we kept the budget under 5%, and again we did that keeping the safety, health and welfare of our residents as our number one priority, and we did it while 1) receiving \$160,000 **less** in state aid than was anticipated; 2) while complying with the **unfunded** state mandates; and 3) while coping with increases in insurance, utilities, some contracts, street, road, and sewer infrastructure improvements, etc., many increases over which we do not have control. Worth noting, for the 5th year in a row, we did not increase our workforce. In fact, in all likelihood it will be decreased across the board this year.
- We continued to seek grant money in an effort to give our taxpayers as much relief as possible.
- We have begun to fund for the first phase of energy efficiency improvements to our buildings, and that will continue on an annual basis.
- In January 2008, ground was broken to begin the Hulfish North Project which will produce 100 rental and/or for-sale town houses and apartments around and above the Hulfish Garage. After waiting 18 years or so (there are a few of us who were around for even single year) it was a joy to see work commence on this project. As I speak, work continues and hopefully by the end of 2010, the entire project will be complete.

- In April, we celebrated the launching of the Borough's Jitney Service. This was after 4 years of anticipation and the time that had elapsed since Borough Council passed a resolution that authorized the Borough to submit an application to NJ Transit to participate in their shuttle service. The jitney service was subsidized by Princeton University while we waited for our permanent jitney from NJ Transit which we do expect any day. Thank you Princeton University for subsidizing this service and thank you to staff and others who worked to make this happen. (To former Councilwoman, Wendy Benchley, who stepped down in March. 2008, how can we not think of you when we mention jitney).
- In June Council was quite busy on the following projects:
- Rezoning the Merwick Tract, which included Menvick, Stanworth, YMCA, YWCA a total of 32 acres, to create a New Zone District to he known as Mixed Use (MX) Zone, which would replace Merwick as we now know it to allow for 125 town house and apartment units for University faculty and staff. The rezoning of the entire tract would permit a combination of multiple dwelling units, non-profit organizations, and other uses within the 32 acres:
- Welcoming the Arts Council back to the Borough in its new home, the Paul Robeson Building;
- Having an in depth discussion on COAH the Council on Affordable Housing and its future in Princeton Borough. The Borough did opt to participate and plans were submitted to COAH on 12-31-08 for certification.
- In August work was begun on Phase 11 of the Redevelopment Project Building C -and while it was delayed for a short period of time while DEP did testing for possible contamination, work started again in December and we hope it will be completed within 12 to 18 months so that residents for the 56 apartments, the live/work units, and small grocery store can move in. Starting mid-year the Borough will begin to collect land rent with an eventual yield of \$300,000 annually.
- In October, we broke ground at 100-104 Leigh Ave. to build five units of affordable housing as the result of a partnership that Princeton Borough had with Princeton University who is responsible for building the units but did contract out with Princeton Community Housing to oversee this project through its completion. Princeton University will then turn the units over to Princeton Borough to satisfy part of their COAH obligation and Princeton Borough will have 5 affordable units to add their housing stock. Hopefully in October or November of this year we will meet again at that site to open the doors of the new units so that residents can move in.
- In October plans were approved by the Princeton Regional Planning Board for a complete renovation and ballroom expansion of Nassau Inn, to include ground floor retail.
- Discussions continued throughout the year regarding the expansion of Princeton University which included traffic, parking, circulation, and their plans for the Arts and Transit Neighborhood that is being proposed. These discussions will continue in 2009 in an effort to approve the best possible plan for this total expansion.

- At the end of 2008, the Borough and Township signed a contract with Appraisal Systems, Inc., who will appraise all real property within the taxing district. Princeton Borough and Township held a joint meeting in December, 2008, during which a detailed explanation of the revaluation process was given after which a question and answer period was entertained. This process will begin the latter part of the first quarter of 2009, and should be completed by October 2009.
- The committee working on the Sustainable Princeton Community Plan since 2007 will be ready to present their Action Plan to the governing bodies at a joint meeting early on in 2009. The goal is to present Princeton as a leader in sustainable communities through its commitment to people, and place.

In 2009, we will continue to set policy that we feel is in the best interest of Princeton Borough, and prioritize the issues in a way that is fair and balanced to all. We know that these difficult economic times will dictate what we can and cannot do as Princeton Borough is not immune from the economic woes being felt by the rest of the country. Municipalities will be expected to do more and more with less and less. To do or not to do is going to be the question facing each municipality as services and funds from the State begin to dwindle more and more. We know that we will have to make more tough choices than ever before. We know that, unlike business, we cannot relocate government. We know that regardless of the economic times residents expect the pot holes to be filled, they expect their streets and neighborhoods to he patrolled, they expect their refuse disposed of, etc., etc. But we also know that we are responsible for the safety and welfare of our residents, and we will continue to make every effort to serve the common good as we provide to our residents the services to which they have become accustom.

It continues to be an honor and privilege to represent you and I look forward to working with Council in these difficult economic times as we strive to make the prudent decisions necessary to make it work for all of us.

Thank you to the staff for continuing to work with me and Council as we endeavor to serve Princeton Borough.

Best wishes to all of you for a healthy and Happy New Year. Please join us at the firehouse on Witherspoon Street for food and lively conversation.

Council President Koontz moved to adjourn; Councilwoman Karcher seconded. There being no further business, Mayor Trotman adjourned the open session meeting at 12:40 P.M.
