Ordinance #2017-2

AN \mathbf{BY} **ORDINANCE** THE MUNICIPALITY **PRINCETON** OF ABOLISHING THE "GENERAL BOARD FOR MAKING ASSESSMENTS **FOR LOCAL IMPROVEMENTS**" **AND AMENDING** THE "CODE OF THE BOROUGH OF PRINCETON, **NEW** JERSEY, 1974" AND THE "CODE OF THE TOWNSHIP OF PRINCETON, NEW JERSEY, 1968."

WHEREAS, the "Code of the Borough of Princeton, New Jersey, 1974" ("Borough Code") and the "Code of the Township of Princeton, New Jersey, 1968" ("Township Code") both provide for a "General Board for Making Assessments for Local Improvements," established for purposes of making assessments for benefits accruing from local improvements in Princeton in the manner provided by law, and pursuant to the provisions of N.J.S.A. 40:56-21 et seq.; and

WHEREAS, the provisions of N.J.S.A. 40:56-21 and N.J.S.A. 40:56-22 provide that the creation of a general board for making assessments for local improvements by a municipal governing body is not mandatory and therefore, is discretionary; and

WHEREAS, pursuant to the provisions of N.J.S.A. 40:56-21 and N.J.S.A. 40:56-22, if a municipal governing body does not create a general board for making assessments for local improvements, the obligation to make assessments for the benefits for local improvements is retained by the governing body, and its obligations and duties in connection therewith are set forth in N.J.S.A. 40:56-21 et seq.; and

WHEREAS, at this time the Princeton Council wishes to abolish the existing "General Board for Making Assessments for Local Improvements" established by the Borough and Township Codes and instead retain the duties and responsibilities to make such assessments for local improvements, as provided by law.

NOW, THEREFORE, BE IT ORDAINED by the Princeton Council as follows:

Section 1. Section 2-86 of Chapter 2 of the "Code of the Borough of Princeton, New Jersey,

1974", entitled "General Board for Making Assessments for Local Improvements," is hereby repealed.

Section 2-113 of Chapter 2 of the "Code of the Township of Princeton, New Section 2.

Jersey, 1968," entitled "General board for making assessments for local improvements," is hereby

repealed.

Section 3. The duties and responsibilities to make all assessments for benefits accruing from

local improvements as set forth in N.J.S.A. 40:56-21 et seq. are hereby retained by the Princeton Council.

Section 4. All ordinances and resolutions or parts thereof inconsistent with this Ordinance are

repealed.

Section 5. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for

any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be

deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of

the remaining portion thereof.

Section 6. The provisions of this Ordinance shall be applicable within Princeton upon final

adoption.

The purpose of this Ordinance is to abolish the "General Board for Making Assessments for Local Improvements" that exists in the municipality of Princeton, and to confirm that the

Princeton Council shall assume the duties and responsibilities for making local assessments as

set forth in the applicable statutes.
