Juvenile Report April 2015

Juveniles Petitioned to Family Court

A sixteen year old female was charged with Burglary after she entered the Cap and Gown Eating Club with an adult male for the purpose of committing a theft.

A fifteen year old male was charged with Possession of CDS and Possession of Drug Paraphernalia with Intent to Use after he was discovered by police with marijuana and a marijuana pipe in Hilltop Park after it was closed.

A fourteen year old boy on probation was charged with Possession of CDS after he was discovered with marijuana while in school.

A 15 year old female, purported member of the Latin Kings street gang, was charged with Aggravated Assault and Obstructing the Administration of Law after she assaulted a police officer by kicking him in the torso and attempting to bite his arm.

A seventeen year old boy was charged with Simple Assault and Criminal Mischief after he purposely damaged his mother's belongings during a verbal argument and threw several objects at her, striking her in the head.

Juvenile Victims

A fifteen year old female reported that she was groped on the buttocks by an unidentified Hispanic male as she walked to school. The matter is under investigation.

An eleven year old boy believed that a Hispanic male waved him towards his vehicle as he was leaving school. The family refused to cooperate with the investigation and would not allow the child to provide a statement to the police.

Juvenile Family Crisis

A fifteen year old girl was transported to the hospital for evaluation after she returned home intoxicated.

An eleven year old girl ran away from home after becoming angry that she had to make her own lunch. She was located at her grandmother's house and reunited with her mother.

A mother requested assistance with her 17 year old son with whom she had a verbal argument during which he threw the phone to the ground. Officers responded and were able to de-escalate the situation.

A 16 year old female was reported missing by her mother after she did not return home for two days after stating she was going to the Princeton Public Library. She was subsequently located at a friend's house in Trenton by police.

Division of Child Protection and Permanency Referrals

A DCP&P referral was made after a fourteen year old boy called 911 to request assistance with his mother who was intoxicated and acting out while caring for his eight year old brother and himself. DCP&P is working with the family and providing services.


April 16th- SNB attended a Committed and Faithful Princetonians meeting at the John Witherspoon Middle School.

- ❖ On Wednesday, April 1, 2015, Cpl. Solovay and K-9 Harris, along with the Princeton Police Department Safe Neighborhood Unit, gave a general police and safety presentation at the Princeton YWCA for their spring break camp. Afterwards, the attendees were given a police K-9 demonstration which focused on obedience and explosives detection.
- ❖ On Tuesday, April 7, 2015, Cpl. Solovay and K-9 Harris attended K-9 Patrol In-Service Training. The training was hosted and conducted by the New Jersey State Police in Hammonton, NJ. The training consisted of environmental exercises, socialization, tracking, criminal apprehension, handler protection, and obedience. The training incorporated a helicopter from the New Jersey State Police.
- ❖ On Tuesday, April 14, 2015, Cpl. Solovay and K-9 Harris attended In-service training for the New Jersey Detect and Render Safe Task Force. The training was hosted by the Burlington County Bridge Commission and conducted by the New Jersey State Police as well as other state certified K-9 Scent Trainers from various agencies.
- ❖ On Saturday, April 18, 2015, Cpl. Solovay and K-9 Harris conducted a K-9 Demonstration at the Princeton Public Library. There were approximately 40 attendees present at the demo. Cpl. Solovay provided a lecture about the K-9 Program detailing the applications, advantages, training requirements, and other aspects of the K-9 Unit. Attendees were also provided with a demonstration involving explosives detection, agility, and obedience.
- ❖ On Wednesday, April 22, 2015, Cpl. Solovay and K-9 Harris conducted a K-9 Demonstration at the Princeton Police Department for the Johnson Park Elementary School kindergarten class visit. The police department's Safe Neighborhood Unit gave a station tour and the attendees were then given a K-9 demonstration in the rear parking lot of headquarters. The demonstration consisted of explosives detection.
- ❖ On Thursday, April 23, 2015, Cpl. Solovay and K-9 Harris conducted a K-9 Demonstration at Community Park South in correlation with "Bring your children to work day." There were approximately 50 attendees at the demonstration. Cpl. Solovay provided a lecture about the K-9 Program discussing the tremendous advantages the K-9 Unit brings to the police department. Attendees were also provided with a demonstration involving explosives detection, obedience, agility, and criminal apprehension. A K-9 Unit from the Federal Bureau of Investigation also gave a demonstration on narcotics detection.

- On Saturday, April 25, 2015 Cpl. Solovay assisted with the Physical Fitness Examination for the Police Department Recruitment Process.
- ❖ On Sunday, April 26, 2015 Cpl. Solovay and K-9 Harris conducted a proactive explosives sweep in preparation for the Communiversity event. K-9 Teams from the Mercer County Sheriff's Office and Kean University assisted with the sweep. K-9 teams remained on scene throughout the event for public safety.
- ❖ On Tuesday, April 28, 2015, Cpl. Solovay and K-9 Harris responded to Riverside Elementary School to assist with an investigation into a "suspicious incident." Further investigation revealed that a non-credible threat was made to the school by an anonymous caller. As a safety precaution, Cpl. Solovay and K-9 Harris conducted a perimeter sweep around the exterior of the school. No suspicious items were located. The incident remains under investigation by the Princeton Police Department Detective Bureau.
- ❖ On Tuesday, April 28, 2015, Cpl. Solovay and K-9 Harris were called to the scene of an aggravated assault on a police officer which occurred on the Princeton University Campus. Originally, it was believed that the suspect had entered a university building and was hiding on the third floor. Cpl. Solovay and K-9 Harris assisted patrol officers with clearing the building, however no suspect was located. Officers on scene located discarded clothing believed to be from the suspect. As a result, a track of the suspect was attempted. K-9 Harris tracked the suspect through the university campus, but lost the scent on Prospect Ave. The suspect was eventually located on Alexander St. by the West Windsor Police Dept. and was taken into custody.
- ❖ On Thursday, April 30, 2015, Cpl. Solovay and K-9 Harris responded to a bomb threat at Hopewell Valley High School after school officials located a threatening message written in a room in the school. K-9 teams from Mercer County responded and cleared the school.
